WEDDING TRIAL PREP

LET'S DO THIS

CLEANSE AND MOISTURISE YOUR FACE IN THE MORNING BEFORE YOUR TRIAL. PLEASE DO NOT USE ANY HARSH EXFOLIANTS OR PEELS THE DAY BEFORE.

WASH AND BLOW DRY YOUR HAIR (OR LEAVE TO DRY NATURALLY) THE EVENING BEFORE YOUR TRIAL. IF YOU HAVE NATURALLY CURLY HAIR AND ARE LOOKING TO HAVE A SMOOTH / STRAIGHT STYLE, PLEASE BLOW DRY YOUR HAIR STRAIGHT THE NIGHT BEFORE. IF YOUR HAIR STYLES BETTER BY WASHING IT A FEW DAYS OUT, THAT IS ALSO FINE

PLEASE NOTIFY ME OF ANY PRE-EXISTING SKIN SENSITIVITIES OR ALLERGIES BEFORE THE TRIAL.

ARRIVE IN A TOP WHICH REPRESENTS THE COLOUR OF YOUR WEDDING DRESS IF POSSIBLE. IT'S CRAZY BUT IT REALLY MAKES A DIFFERENCE!

PLEASE BRING ALONG SOME PHOTOS OF HAIR AND MAKEUP PHOTOS AS INSPIRATION, EVEN IF IT IS JUST 1 OR 2. PHOTOS OF YOURSELF WHEN YOU HAVE LIKED YOUR HAIR / MAKEUP IS ALSO GREAT

YOU ARE WELCOME TO BRING ANY HAIR ACCESSORIES YOU MAY WANT TO INCORPORATE. YOU ARE ALSO WELCOME TO BRING A VEIL, HOWEVER, THIS IS NOT OBLIGATORY

WE TRY TO ENSURE THAT TRIALS ARE DONE IN THE MORNING TO ALLOW SUFFICIENT TIME FOR THE HAIR AND MAKEUP TO SETTLE AND 'WEAR' THROUGHOUT THE DAY. THIS ALLOWS YOU TO SEE IF THERE IS ANYTHING THAT NEEDS TO BE CHANGED OR TAKEN INTO CONSIDERATION

WE RECOMMEND TRIALS TO BE DONE 3-6 MONTHS OUT FROM THE BIG DAY, HOWEVER, THAT'S JUST A GUIDELINE

PLEASE FEEL FREE TO ASK ME ANY QUESTIONS IN THE LEAD UP TO THE TRIAL, AND I CAN'T WAIT TO PAMPER YOU!
